### QUALIFICATIONS

- Holds or is able to obtain a valid dental license with the Dental Board of California
- Graduated from an accredited pediatric residency program
- No history of sanctions from any dental board
- Current CPR and or PALS certificates, malpractice certificates
- Authorized to work in the USA
- Two years of experience preferred, but not required

## **DUTIES AND RESPONSIBILITIES**

- Provide dental treatment according to the standards set for by the American Dental Association and the American Association of Pediatric Dentistry
- Collect and review data and accurately and assess it to determine the best path of treatment for the individual patient. This includes x-rays, intra-oral photos, visual exams, etc.
- Perform routine and emergency dental care, diagnosis and treatment planning, patient exams and prophylaxis
- Provide oral health education to assist patients with establishing good oral health habits
- Practice behavior management in a compassionate manner to ensure successful dental visits.

- Provide quality treatment and a quality experience to all patients
- Ensure accuracy in the recording of each dental visit and provide all information necessary for reimbursement by Medi-Cal Dental
- Follow up with parents/guardians as needed
- Obtain privileges at local hospitals for patients requiring hospital administered general anesthesia
- Attend monthly staff meetings; give and receive input from all staff with the common goal of improving TCDC
- Adhere to all established protocols, OSHA, HIPAA and government regulations
- Show respect for all members of the TCDC team, parents/guardians and patients
- Work efficiently and effectively by managing time well, using good judgment, and maintaining composure in response to emotional and emergent situations
- Maintain open communication with the Dental Director and the Executive Director
